Inspector Observations: Observed the rice cooling being placed in deep containers and about to be covered when still hot. [CA] Cool with approximately 2 inches of food deep, not in the deep containers. Leave uncovered on a top shelf in the refrigerator until cool. Went over proper cooling with employees.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed the scooping spoons to be left in the bulk food containers with the handles on the food. [CA] Store them with the handles not touching the food.
