Major Violations

No major violations were observed during this inspection.

Facility lacks testing materials for their choice of sanitizer.

[CA] Testing equipment and materials shall be provided to adequately measure the applicable sanitization method used during manual or mechanical warewashing.

Inspector Observations:

Facility has cold plates installed in ice bins with ice meant for consumption.

[CA] Beverage tubing and cold-plate beverage cooling devices shall not be installed in contact with stored ice intended to be used for food or beverages.
