## Comments and Observations

### Major Violations

K07 - 8 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: goulash, chicken wings in 2 door prep cooler at 51F. all perishable food items moved to walk in cooler. advised operator not to store perishable food in the unit until serviced**

**[CA]maintain perishable food under 41F (or 45F for dairy products) cream cheese, pastrami at 46F in walk in cooler**

**[CA]maintain perishable food under 41F (or 45F for dairy products) schweinshaxe in hot cabinet at 120F. corrected during inspection**

**[CA]maintain perishable hot food above 135F**

### Minor Violations

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: leaking from 3 compartment sink next to dishwashing machine**

**[CA]maintain plumbing in good repair**
