**Follow-up inspection to limited inspection conducted by Jennifer Rios on 3/15/2023 which resulted in a closure due to vermin.**

**Facility received professional pest control treatments on the night of 3/15 and morning of 3/16.**

**Two dying cockroaches were observed at the time of inspection, no further evidence of vermin was observed within the facility.**

**Continue working on eliminating vermin harborage points within the kitchen.**

**Facility is reopened and may resume operation.**
