## Comments and Observations

### Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations:** *Lack of paper towel at the restroom hand wash sink. [CA] Single use paper towel shall be provided at hand wash sink at all times. [COS] Operator provided paper towel at restroom hand wash sink.*

### Minor Violations

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

**Inspector Observations:** *Measured hot water at restroom hand wash sink at 63F. [CA] Handwashing facilities shall be equipped to provide minimum 100°F water under pressure for a minimum of 15 seconds. Adjust the hot water so that it measures at 100F.*

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

**Inspector Observations:** *Observed restroom door propped open. [CA] Restroom shall be equipped with well-fitted, self-closing doors that prevent the passage of flies, dust, or odors.*

All responses to PBI questions were satisfactory.
