K15 - 8 Points - Food not obtained from approved source; 113980, 113982, 114021-114031, 114041

**Inspector Observations: Observed the following prepackaged food items kept out in ambient temperature, offered for sale for customer self-service without proper labels and documentation (invoices).**

- 31x - different types of prepackaged sweet and savory sticky rice.
- 6x - prepackaged " Banh Ca Vat" - deep fried bow-tie cookies.
- 32x - cups of different types of "che" - dessert pudding/soup dumplings - containing coconut milk, bananas, mung bean, corn, etc.
  - 14 of the 32s cups of "Com Ruou" - fermented rice ball dessert, maintained inside the display refrigerator behind the counter.
- 25x - cups of Vietnamese jello - maintained inside the merchandiser refrigerators on the sales floor.
- 10x - "Banh Chung" - sticky rice with mung beans, and meat wrapped in banana leaves.
- 31x - different types of prepackaged "Banh Da Lon" - steamed tapioca layer cake.
- 9x - different types of prepackaged "Banh Bo" - steamed rice cake
- 10x - different types of "Banh Duc" - savory rice flour pudding.

**PIC was unable to provide invoices or documentation of where the prepackaged food from provided from.**

**[CA] Food must be from an approved source or properly documented.**

**[COS] All items were removed from the sales floor and VC&D.**
