A routine inspection was conducted on 06/22/2026. During the 2nd follow-up inspection, cockroaches were observed in this facility and health permit was suspended. A 3rd follow-up inspection was conducted today.

No cockroaches were observed at time of this inspection.

Pest control reports were reviewed. Pest control service was provided by Baypest Solution on 07/24/2026. A follow-up service was provided in the morning of 07/25/2026. Report dated 07/25/2026 noted "no live roaches". Report also noted that another follow-up service will occur next week to apply preventative bait treatment.

Facility appeared to have been thoroughly cleaned.

Health permit to be re-instated. Facility is okay to operate.

FACILITY RE-OPENED / PERMIT REINSTATED
