## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

#### **Inspector Observations:**

**Second Repeat Violation: Facility lacks food handler cards for staff.**

**[CA] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.**

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

#### **Inspector Observations:**

**The soap dispenser at the only handwash station is in disrepair. A pump bottle of soap was available.**

**[CA] Provide handwashing cleanser in dispenser at handwash stations at all times.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

#### **Inspector Observations:**

**Facility lacks drain plugs to fill basins of the two compartment warewash sink. Facility was using aluminum foil to plug the drain.**

**[CA] Plugs/stoppers shall be available to fill up the warewashing sink.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

#### **Inspector Observations:**

**Shirts and towels were found stored over bags of flour in the dry storage room.**

**[CA] No person shall store clothing or personal effects in any area used for the storage and preparation of food or food contact surfaces.**
