## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

**Inspector Observations: The maximum water temperature on the janitorial sink was measured at 80 oF.**  
**[CA] Adjust the water heater temperature to raise the water temperature on the janitorial sink to 120 oF.**

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

**Inspector Observations: Couple of drain flies were observed back in the warehouse.**  
**[CA] Eliminate vermin from the facility by a legal method.**

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

**Inspector Observations: There was no functional thermometer inside of the triple door upright fridge where milk is stored.**  
**[CA] To monitor the ambient air temperature of the units, please install a functional thermometer on all refrigeration units.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: There is a heavy stain buildup on the floor sinks located below the three compartment sink and beverage walk-in cooler.**  
**[CA] Conduct a thorough cleaning on the floor sinks immediately.**
