Inspector Observations:

In the bar area, in both refrigerated drawer units, the top drawer contained shattered glass pieces while the bottom drawer had an open container of ice. The top drawer has openings that lead to the bottom drawer. No contamination of ice observed.

[CA] All food shall be separated and protected from possible contamination. Provide lids for the containers of open ice.

[COS] Staff removed the glassware and cleaned the top drawers of glass. Lids were provided for the containers of ice.
