### Major Violations

**Inspector Observations: FOUND A COUPLE OF PLASTIC CUPS INSIDE THE HAND WASH SINK IN THE FRONT. [CA] KEEP THE HAND WASH SINK ACCESSIBLE AT ALL TIMES.**

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: FOUND A FEW SACS OF PIZZA FLOUR STORED ON THE FLOOR IN THE BACK. [CA] STORE FOOD 6 INCHES ABOVE THE FLOOR.**
