## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: No food handler card or FSC available. [CA] At least one employee must have a FSC and all others working with the open food must have a food handler card.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations: Observed the sanitizer at the dish sink to be at 100ppm quat. [CA] It is to be at 200ppm quat. Use manual sanitization until it can be adjusted. Fill the dish sink with sanitizer at 200ppm quat by purging it in or using chlorine at 100ppm. Obtain and use the test strips each time the sanitizer is used.**
