Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: The wiping towels were in 50-100ppm quat. [CA] Keep the sanitizer level at 200ppm quat. [COS] The towel buckets were changed out to 200ppm quat.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floor to have thick accumulation and debris on the side of the ice machine next to the walk in. [CA] Thoroughly clean the floors around the ice machine.
