Inspector Observations: REPEAT VIOLATION:

Rodent dropping observed behind shelves on beam. Per operator pest control come regularly and will be by to add traps and doors were sealed recently.

[CA] Clean and sanitize area of dead cockroaches or old droppings. Increase frequency of pest control and monitor for signs of new vermin activity.

[COS] Rodent droppings were removed and areas were sanitized. Follow up inspection will be conducted in July due to repeated violation.
