### Major Violations

No major violations were observed during this inspection.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

#### ***Inspector Observations:***

***1. Old debris accumulation observed around the express oven.***

***[Corrective Action] Thoroughly clean and maintain clean.***

***2. White crystalline accumulation on the dishwasher.***

***[Corrective Action] Thoroughly clean and maintain clean.***

***3. Dust accumulation on the vent guard on the ceiling at the dishwasher area.***

***[Corrective Action] Thoroughly clean and maintain clean.***

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

#### ***Inspector Observations:***

***Water squirts out from the base of the faucet at the prep sink when water is turned on.***

***[Corrective Action] Repair the faucet.***

### Overall Comments:

***Food prep was observed at the 3 compartment sink. The 3 compartment sink is indirectly connected to the floor sink. All utensils are washed at the dishwasher machine. Reminded PIC that there shall be no food prep at the 3 compartment sink if there is active warewashing at the 3 compartment sink.***

***Discussed utilizing fly trays, UV light, air curtain since front and side doors are left open.***

***A routine inspection was conducted in conjunction with a complaint investigation.***

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **6/26/2025**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
