FINDINGS: THE FACILITY NOW HAS HOT WATER AT 120F AT THE 3 COMPARTMENT SINK AND 100F AT THE HAND WASH SINK. OK TO RE-OPEN

NOTE: UPON ARRIVAL TO THE FACILITY, THERE WERE CUSTOMERS EATING AT THE TABLE. FOOD WORKERS WERE PREPARING HOT SAUCE, AND THE BEANS AND CARNITAS WERE ALREADY COOKED PRIOR TO RE-OPENING. THE RED PLACARD WAS POSTED UPON AT TIME OF INSPECTION.
