FOLLOW UP INSPECTION FROM 7/23/24 IN WHICH THE WALK IN COOLER WAS UNABLE TO KEEP THE POTENTIALLY HAZARDOUS FOOD AT 41F OR BELOW.

FINDINGS: THE REFRIGERATOR WAS SERVICED, PER OPERATOR. HOWEVER, IT IS NOT KEEPING THE POTENTIALLY HAZARDOUS FOOD AT 41F OR BELOW. NOTE: DO NOT USE THIS COOLER AND TRANSFER THE POTENTIALLY HAZARDOUS FOOD TO A WORKING REFRIGERATOR.

THIS RE-INSPECTION WILL BE FREE OF CHARGE. THE FOLLOWING RE-INSPECTION WILL BE CHARGED \$298 PER HOUR MINIMUM 1 HR.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
