Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: *There is not a handwashing sink in the kitchen. [CA] There must be a hand sink in the kitchen. The dish washing sink is being used to wash dishes, hands, and food prep.*

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: *The gasket on the chest freezer is broken and falling off. [CA] Replace/ repair the gasket.*

Overall Comments:

There are ice blocks here but not being used. Please use the ice blocks for keeping potentially hazardous foods cold. Obtain enough ice blocks for the salad bar and serving table.
