Major Violations

No major violations were observed during this inspection.

Minor Violations

Inspector Observations: Found leaking faucet at hand wash station located in front of oven. [CA] Secure leak.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Found flooring throughout prep and cooks area with damaged floor that may lead to potential trip hazard. [CA] The floor surfaces shall be smooth, of durable construction, and of nonabsorbent material that is easily cleanable.


