FINDINGS: THE FACILITY WAS TREATED, PER OWNER BY A PEST CONTROL BAY PEST CONTROL ON SATURDAY. THE MAJORITY OF THE GAPS AND CREVICES ON THE CEILING WERE ADDRESSED. CONTINUE TO WORK ON THE WALL CREVICES AND HOLES.

THERE IS NO EVIDENCE OF COCKROACHES AND MICE. OK TO RE-OPEN. THERE MAY BE A FEE FOR TODAY'S RE-INSPECTION.

THE OVERDUE PERMIT FEE WAS PAID (RECEIPT WAS SHOWN).
