Comments and Observations

Major Violations

K14 - 8 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: *Plastic guard of the ice machine was observed to have pink mold like residue with the level of ice at the level of the plastic guard. [CA] The food-contact surfaces of all equipment shall be kept free of encrusted grease deposits and other soil accumulations. [COS] PIC cleaned and sanitized it.*

Minor Violations

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: *One light bulb in the front cook line over stove was in disrepair. One light bulb in the rear cook line over deep fryer was in disrepair. [CA] Repair/ Replace light bulb*

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: *Wiping cloth was not stored inside the wiping bucket. [CA] Wiping towels shall be stored in sanitizing solution of an approved concentration when not in use (100 ppm - chlorine, 200 ppm - quaternary ammonium).*
