K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: Unable to verify food safety program/food handler cards for all working employees.**  
**[CA] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.**
