Inspector Observations: At time of inspection, five cockroach observed that were still moving but on their backs. Four around the dishwasher and one by the walk-in cooler. ~10-20 dead cockroaches observed in the kitchen. Observed around the dishwasher, under the prep table along the wall, under the prep table next to cook line, inside baseboard of the walk-in cooler, by the walk-in cooler door, in the prep sink by the cook line. [CA] Facility shall be kept free of vermin and vermin debris.

Inspector Observations: An unapproved outdoor tent was set up with tables, handwash station, two flat top grills, and two propane grills used to prepare food. Tent was set up with only 3 walls from plastic sheets. [CA] Facility shall not prepare food in an unapproved and unpermitted location. Cease and desist all food preparation .

Overall Comments:

Facility is CLOSED due to vermin infestation and shall cease all food operations. Facility will remain closed until there is no longer evidence of a vermin infestation.

Follow-up inspection requested for CDPH as cockroach activity was observed. Kitchen was self-closed at time of inspection. However, it was observed that facility was preparing food in an unapproved outdoor area. Facility was instructed to immediately cease all food prep operations.

Facility is ONLY allowed to serve PREPACKAGED food obtained from another permitted facility or permitted food truck until vermin infestation is resolved and a re inspection is conducted by this department.

At time of inspection, five cockroach observed that were still moving but on their backs. Four around the dishwasher and one by the walk-in cooler. ~10-20 dead cockroaches observed in the kitchen. CLOSURE / PERMIT SUSPENSION NOTICE


When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **2/12/2024**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
