 - *Facility has cleaned and sanitized all affected areas.*
 - *At time of follow-up inspection, no live or dead activity was observed.*
- *Facility is hereby authorized to reopen and resume operations.*
- *This Division recommends:*
 - *Maintaining service twice per month, or as frequently as possible to mitigate infestation, and then reducing frequency as preventative measures.*
 - *Sealing all holes, gaps, cracks, and/or crevices to prevent harborage.*
 - *Replacing any remaining cardboard boxes with plastic containers with lids.*
- *Prior to reopening, conduct final cleaning and sanitization of all food and non-food contact surfaces.*
- *Continue to address all other violations noted on previous inspection report.*

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **8/22/2024**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
