Overall Comments:

On 03/03/2021 a second follow-up inspection was conducted onsite at the facility listed above. The purpose of this second follow-up inspection was to evaluate whether the facility had corrected the violations identified during the initial 02/26/2021 inspection and during the first follow-up inspection on 02/28/2021.

At the time of the first follow-up conducted on 02/28/2021 the facility was found to be in operation despite of having a suspended operating permit.

As of the time of the second follow-up inspection on 03/03/2021, the facility has corrected the violations of the public health orders stated on 2/26/21 and 2/28/2021 inspection reports.

At this time Santa Clara County is operating under the Red Tier of the State Blueprint for a Safer Economy. Currently the facility is permitted to operate indoor at 25% of its normal indoor capacity. Under the County's revised Mandatory Directive on Capacity Limitations the facility is required to post signage at each entrance indicating its Reduced Maximum Capacity. All signage as required by the Public Health Order shall be posted prior to resuming operation.

The facility has been reopened and permit is reinstated at this time. However, further enforcement action may be taken for the facility's operation on 02/28/2021 while its operating permit was suspended.

The facility must continue to comply with the public health orders. Any further violations of the public health orders may lead to further permit suspension or revocation.

Note: This is a second follow-up inspection and shall be billed at the rate of 219/hr as approved by the Board of Supervisors.

FACILITY RE-OPENED / PERMIT REINSTATED


When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **3/17/2021**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
