Major Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: Food safety managers certificate on file expired 5/2024. [CA] Renew immediately, at least one person shall be food safety certified.

K09 - 3 Points - Improper cooling methods; 114002, 114002.1

Inspector Observations: Observed rice at 145F cooling in a full plastic covered container on counter. [CA] Cool foods rapidly by leaving uncovered in shallow metal pans, with solid foods no more than 2 inches high, liquids no more than 4 inches. [COS]

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: Observed ready to eat container of food below raw meat in refrigerator in dry storage room. [CA] Store ready to eat food above raw meat. [COS]

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Cans of food stored directly on floor in dry storage room. [CA] Store food 6 inches off of the floor.
