## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

#### **Inspector Observations:**

***Utensils used to scoop rice and mix chicken were observed stored in room temperature water.***

***[Corrective Action] Store utensils in water at 135 degrees Fahrenheit or above.***

K47 - 2 Points - Signs not posted; last inspection report not available; 113725.1, 113953.5, 113978, 114381(e)

#### **Inspector Observations:**

***1. Health permit not posted in public view.***

***[Corrective Action] Post the current valid health permit in public view.***

***2. Lack of handwashing sign in the restrooms.***

***[Corrective Action] A sign or poster that notifies food employees to wash their hands shall be posted at all handwashing stations used by food employees.***
