A professional pest control service was conducted on 4/28/2025 at 12:40 pm. Per pic a contact time of 3 to 4 hours was allowed prior to cleaning.

No live cockroaches observed at the time of inspection.

The potential entry and vermin harborage points have been repaired:

- 1. Rear door to the facility adjusted and door sweeps added.*
- 2. All drain clean-out covers sealed/ replaced. Floor drain screens replaced.*

Continue to work on minor violations noted during the routine inspection.

Facility is reopened and may resume operation.

FACILITY RE-OPENED / PERMIT REINSTATED
