Fifth follow-up inspection to a limited inspection resulting in a closure due to vermin on 9/14/2020.

Facility stated that they received multiple professional pest control treatments fogging/spraying and baiting. Facility plans to have daily pest control treatments to ensure no further activity arises.

Cockroach activity was eliminated from the facility.

Two dying cockroaches were eliminated at the time of inspection. Ensure all food preparation surfaces were cleaned and sanitized prior to resuming food preparation.

Facility is reopened and may resume operation.

Continue to work on correcting any remaining structural issues and deep cleaning areas with the build-up of food debris leading to the harborage of vermin.

Facility will be charged for 4 follow-up inspections at \$219.00 each. Total of \$876.00 will be billed to the facility.

When required to determine compliance, a single reinspection will be conducted without additional charge.
