Inspector Observations: LIVE COCKROACHES (OF ALL LIFE STAGES) OBSERVED AT THE FOLLOWING LOCATIONS: 5-6 AT WALL BEHIND METRO SHELF NEAR MECHANICAL WAREWASH MACHINE. 1 COMING OUT OF ELECTRICAL OUTLETS ALONG FOOD PREP AREAS AND 3 NEAR WALK IN FREEZER ON THE FLOOR NEAR PANTRY. PIC INDICATED THEY HAVE HAD PEST CONTROL WORKING ON THE ISSUE FOR THE PAST FOUR DAYS. EXCESS AND HEAVY BUILD UP OF GREASE NOTED ALL ALONG COOK LINE HALF WALL. [CA] THE PREMISES OF EACH FOOD FACILITY SHALL BE KEPT FREE OF VERMIN. A FOOD FACILITY SHALL NOT OPERATE WHEN THERE IS A VERMIN INFESTATION THAT HAS RESULTED IN THE CONTAMINATION OF FOOD CONTACT SURFACES, FOOD PACKAGING, UTENSILS, FOOD EQUIPMENT, OR ADULTERATION OF FOODS. THE FOOD FACILITY SHALL CEASE OPERATION OF THE FOOD FACILITY IMMEDIATELY. THE FOOD FACILITY SHALL REMAIN CLOSED UNTIL: THERE IS NO LONGER EVIDENCE OF A VERMIN INFESTATION; ALL CONTAMINATED SURFACES HAVE BEEN CLEANED AND SANITIZED; THE CONTRIBUTING FACTORS SUCH AS CLEANING, REPAIRS, AND THE ELIMINATION OF HARBOURAGES HAVE BEEN RESOLVED.

## **CLOSURE / PERMIT SUSPENSION NOTICE**
