Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Raw pooled eggs stored in prep fridge insert measured at 46F. Per operator, eggs were placed in prep fridge insert one hour prior.

[CA] Potentially hazardous foods shall be held at 41°F or below or at 135°F or above.

[SA] Raw pooled eggs were moved inside prep fridge.

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: Chlorine sanitizer in mechanical warewash machine measured at 25ppm. Operator contacted technician for same day service. Food employees were instructed to not use dishwasher until it is properly serviced.

[CA] Maintain chlorine in mechanical warewash machine at 50 PPM.

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

**Inspector Observations: *Repeat violation*
In the walk in cooler, raw meat was stored above ready-to-eat foods.**

[CA] All food shall be separated and protected from cross-contamination. Ensure all raw meat is stored below ready-to-eat food items.

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: *Repeat violation*
Multiple food containers stored on walk in cooler floor.**

[CA] Food shall be stored at least 6 inches above the floor to prevent contamination.

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: On the cook line, several wet wiping cloths were stored on counter.

[CA] Wiping cloths shall be stored in sanitizing solution of an approved concentration when not in use. (100ppm - chlorine)

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: *Repeat violation*
In the dry storage area, employee personal belongings found stored on shelves next to food items.**

[CA] Personal belongings shall be stored in a designated area that will prevent the potential contamination of food and food contact surfaces.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Accumulation of food debris observed on floors under cooking equipment and shelves.

[CA] Routinely clean and sanitize under cooking equipment and shelves to prevent debris buildup.
