Major Violations

[CA] PHFs shall be held at 41°F or below or at 135°F or above.**

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: Faucet closest to the dish washer is leaking once turned on.
[CA] Repair plumbing fixture and maintain in clean and good repair.**
