Comments and Observations

Major Violations

K07 - 8 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: *Measured sliced ham/cheese at sandwich prep unit at 50F, items were stacked above the load line at table top insert. [CA] Maintain potentially hazardous food 41F and below. Do not overfill containers at sandwich unit*

Minor Violations

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: *Observed pooled raw eggs stored above cut tomatoes in 2 door upright back unit. [CA] Store raw eggs below ready to eat food.*
