Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 114125(b), 114141

Inspector Observations:

Chlorine sanitizer concentration in the dishwasher was measured at 10 ppm.

[Corrective Action] Maintain chlorine sanitizer concentration at 50 ppm.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations:

Grime accumulation on the rubber seals and interior of the 3 door upright cooler and the single door upright cooler.

[Corrective Action] Thoroughly clean.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

1. Broken or missing floor tiles observed at the cookline.

[Corrective Action] Repair or install floor tiles.

2. Heavy grease accumulation on the floor under the deep fryer.

[Corrective Action] Thoroughly clean.
