Major Violations

Inspector Observations:

Heavy dust accumulation on the fan guard in the customer restroom.

[Corrective Action] Thoroughly clean and maintain clean.

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

Inspector Observations:

Toilet paper not observed stored in the toilet paper dispenser in the restrooms.

[Corrective Action] Store toilet paper in the toilet paper dispenser.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

Observed staining and clutter on the floor in the merchandiser/walk-in cooler.

[Corrective Action] Clean and maintain walk-in free of clutter.
