Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations:

Observed roll of paper towel stored on the shelf across from the handwash sink in the kitchen. PIC placed the roll of paper towel in the paper towel dispenser however the dispenser does not work properly.

[Corrective Action] Replace the paper towel dispenser and store roll of paper towels in the dispenser.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations:

Pressurized cylinder at the bar area observed not secured to a rigid structure.

[Corrective Action] Secure the pressurized cylinder to a rigid structure.
