Major Violations

No major violations were observed during this inspection.

Inspector Observations: Hot water 111F at the three-compartment sink [CA] Maintain hot water at 120F or warmer

Inspector Observations: Cream cheese container lack label [CA] Provide label. Label information shall include the following:

- (1) The common name of the food, or absent a common name, an adequately descriptive identity statement.
- (2) If made from two or more ingredients, a list of ingredients in descending order of predominance by weight, including a declaration of artificial color or flavor and chemical preservatives, if contained in the food.
- (3) An accurate declaration of the quantity of contents.
- (4) The name and place of business of the manufacturer, packer, or distributor.
