Note: This is a follow-up inspection for the routine inspection conducted on 08/27/26. The facility was issued for blocking the handwash station located back in the kitchen and for conducting food preparation on unclean three compartment warewash sink. Both violations were observed to be addressed today.

However, none of the minor violations cited during the time of the routine inspection are not addressed. During today's inspection, diced tomato stored on the preparation table was measured at 51 oF. In addition to these, employees were observed not to wash in between touching unclean surface and open food products.

Therefore, the facility shall stay on a conditional pass. Today's inspection is conducted free of charge. However, any upcoming follow-up inspection shall be conducted at a charge of \$282.00/ hour for a weekday work hours. Please contact the district inspector for a follow-up inspection.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **9/16/2026**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
