## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Single use paper towels do not dispense from installed dispenser.**

**[CA] Single-use sanitary towels shall be provided in dispensers; heated-air hand drying device may be substituted for single-use towels.**

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

**Inspector Observations: Door on preparation refrigerator is in disrepair.[CA] Maintain equipment clean and in good repair.**

**Inspector Observations: Pizza cutter and knives found stored wedge in cardboard box.**

**[CA] Properly store utensils and equipment in a clean and sanitary manner.**
