Major Violations

No major violations were observed during this inspection.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: FOUND EXCESSIVE MOLD LIKE SUBSTANCE ON THE INSIDE WHITE PLASTIC FLAP OF THE ICE MACHINE. [CA] CLEAN THIS PART MORE OFTEN. DO NOT USE THIS ICE TO BAG IT AND SELL AS CONSUMABLE ICE AS THERE IS NO 3 COMPARTMENT SINK TO WASH, RINSE AND SANITIZE THE SCOOP.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: FOUND GAPS UNDER AND OVER THE BACK DOOR GREATER THAN A QUARTER OF AN INCH. [CA] REDUCE THE GAPS TO LESS THAN A QUARTER ON AN INCH.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: FOUND THE FLOORS NEAR THE BACK DOOR WITH TRASH. [CA] CLEAN THE FLOORS MORE OFTEN.
