This is a follow up inspection to verify that all major violations mentioned on 7/23/25 inspection report have been addressed. Major violations have been addressed and found within compliance:

- K07: Proper hot and cold holding temperatures. Facility has decided to remove reach in refrigeration from the facility. Reach in has been removed. If facility decides to add an additional refrigeration; must be like for like.

- K08: Time as a public health control; procedures & records. Facility has TPHC form posted in the front of the facility and is time marking all food with stickers. Continue on time marking food items.

- K14: Food contact surfaces clean, sanitized. Scoops have been placed on ice and will be changed out within 3-hours of use.

Continue on working on any other violations mentioned on 7/23/25.



If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
