Overall Comments:

This is a follow up inspection to to verify that Major violations mentioned in 6/23/22 inspection report have been addressed. Facility still has vermin activity within facility:

K23: No rodents, insects, birds, or animals. Observed four nymph/adult coach roaches within facility at the time of inspection. Dead coach roaches under 3-compartment sink and behind reach in refrigeration.

One nymph located within prep table gasket, adult in reach refrigeration gasket, nymph within 3-compartment sink, and adult around the dry storage area.

- Recommend ceiling any holes around facility and cleaning/sanitizing more frequently.

- PIC provided pest control report dated 6/22/22. Facility has pest control come in once a month. Recommend having pest control come into facility two times within the month for the next 4-5 months.

- Facility has requested a follow up inspection on (6/25/22), on the weekend. A charge of \$219 will be chargeable for the follow up inspection conducted today. Also a \$493 per hour charge for the weekend follow up inspection because it will take place during non-business hours and minimum 1-hour.

Facility is to remain closed by this department.
