### Major Violations

**Inspector Observations: HANDLE OF RICE SCOOP WAS INSIDE THE WATER CONTAINER.**

**[CA] Store handle in away that it will stay out of the water container and can easily grab.**

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

**Inspector Observations: TWO DIRTY WIPING CLOTHS WERE LEFT THE COUNTER AT THE TWO DIFFERENT LOCATIONS.**

**[CA] After use, wiping towels shall be stored in sanitizing solution of an approved concentration when not in use (100 ppm - chlorine, 200 ppm - quaternary ammonium).**

### Overall Comments:


