K23 - 8 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: *Observed droppings on the back of the shelf behind the jars of bbq sauce and in the warehouse. None observed on the food or beverage. [CA] Take effective measures to eliminate rodents from inside the facility. Continue with the pest control service. All food storage shelf was cleaned and sanitized during inspection. Protect food from possible contamination by storing on the higher shelves. Manager had food and beverage moved to higher shelves in the warehouse.*
