- Observed no live or dead activity with the exception of one dead cockroach on the wall between the hand wash sink and three-compartment sink.

- Facility will continue with pest control service vermin is completely abated.

- Facility is hereby authorized to reopen and resume operations.

- Continue to clean and maintain facility free of vermin.

- Prior to reopening, conduct final cleaning and sanitization of all food and non-food contact surfaces.
