Major Violations

No major violations were observed during this inspection.

Minor Violations

K05 - 3 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

Inspector Observations: Observed employee drop something on the floor; picked it up and did not wash hands. Headed over to food prep.

[CA] Properly wash hands with soap, warm water and dry using single use paper towels as required.

[SA] Specialist instructed employee to wash hands when dropping anything on the floor and picking it up.

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: Sanitizer bucket was measured at 0PPM at the time of inspection.

[CA] Wiping towels shall be stored in sanitizing solution of an approved concentration when not in use (100 ppm - chlorine, 200 ppm - quaternary ammonium).

[COS] Buckets were changed out; re-measured at 200PPM.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Hole noted on top ceiling panel by the water heater.

[CA] Repair holes in structure and maintain in good repair to prevent pest harborage.
