Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K05 - 3 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

Inspector Observations: Employee observed cleaning and various other tasks then return to the cook line without washing their hands. [CA] Employees shall properly wash hands prior to handling food or food contact surfaces. [COS] Employee was stopped before contaminating food and asked to properly wash hands.

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Handwash sink in the back prep area is partially obstructed by equipment. [CA] Handwash sink shall be kept unobstructed and easily accessible to allow employees to wash their hands when required.

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Containers of food observed stored on the floor under the reach-in cooler. [CA] Food shall be stored a minimum of 6 inches off the floor.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed boxes of food bags and boxes of disposable gloves for food handling stored inside the employee restroom. [CA] Food contact equipment shall be stored in a location where it is protected from contamination.

Overall Comments:


