Inspector Observations: At least one employee must have a food safety certificate. The employee that has one has expired. Please have the other employees obtain a food handler card

Inspector Observations: The hand sink is full of items. [CA] Remove the items from the hand sink so that it is easily accessible and used.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed the floor in the walk in to be soiled with debris in the corners, under shelves. [CA] Thoroughly clean the shelves.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floor to have mildew under equipment and in the corners. [CA] Clean the floors throughout and floor sink.
