## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

**Inspector Observations: Observed lights out in various places in the kitchen, food storage areas, and under hood.**

**[CA] Replace all of the lights that are out.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: Observed personal belongings out on tables. [CA] Store them in a designate area for personal belongings.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: Observed the floor to have some old food on the floor in the storage areas. [CA] Clean the floor in the storage room.**

**Observed the floor to have mold like buildup near the portable grease bin. [CA] Clean and sanitize the floor.**

**Observed the ceiling above the dish machine to be accumulating mildew. The ceiling tiles above the drink dispenser in the left side wait station is deteriorated. Cover the ice and replace the deteriorated ceiling tile. [CA] Replace these ceiling tiles.**
