Facility was closed on 10/19/2022 by Henry Luu due to vermin infestation.

Observed a pest control service report (Banner Pest Services) on 10/20/2022 stated the kitchen received full service of pest control. On the pest control report, it stated service was provided under all appliances, check for cockroach activity, and set up monitor for activity.

No cockroach found today in the kitchen. On site discussion with Javier Hernandez, Banner Pest Services Commercial Account Executive, regarding proposed service schedule for the facility. He stated facility will have another pest service on Monday 10/24/2022. Facility must maintain regular pest control service to eliminate cockroach activities.

Observed hand wash stations are stocked with soap and paper towels.

Facility is ok to re-open.

An invoice of \$493.00 for this inspection will be mailed.


